- 5. As admission counsellor, you will guide and assist the prospective students seeking admission in the University in various open and distance learning programmes. While guiding and assisting the students, you will provide complete information regarding the University and also various ODL courses/programmes in which a student may be winterested desirous of seeking admission.

- 6. You will provide all necessary support and guidance to students in the process of their admission in various ODL programme in the University and assist them in completion of various formalities / procedure of admission.
- 7. You will strictly follow and abide by all necessary instructions / directions and norms of the University as may be issued from time to time in relation to your duties and functional requirements.
- 8. While working as admission counsellor, you will keep the University fully indemnified for any or all liability which may arise out of any inaction, wrong action, deficient action, illegality which may arise on your part.
- 9. You will also actively assist the University in dissemination of information and promotion of various ODL programmes / courses of the University, with the prior approval of the competent authority of the University.
- 10. While working as admission counsellor, you will not use any material or confidential information of the University without due prior approval of the competent authority of the University in writing. You will not disclose any information / data provided to you by the University to any other institution whether orally, in writing or in any other manner as may be possible.
- 11. The University reserves its right to terminate the appointment without assigning any reason and by giving notice of fifteen days in writing. However, if it's come to the knowledge of the University that you are working against the interest of the University or you are acting in any manner which may cause or causing damage to the reputation / interest of the university, then in such an event, your appointment shall stand terminated automatically forthwith and all liabilities arising therefrom, shall rest on you.
- 12. In case of any dispute, the area of juridiction will be Distt: Amroha (U.P).
